There are strict requirements to let patients know if an MCO is no longer contracting with a certain medical provider and a transition plan has to be in place for a member if they move from one MCO if the patient requests another MCO in order to continue seeing the medical provider Tallie Tolen handed out the Community Benefits brochure.
