RE: Tribal Notification to Request Advice and Comments Letter 21-19: Third Party Liability

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Human Services Department's (HSD's) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HSD, through the Medical Assistance Division (MAD), is accepting comments until **5:00 p.m. Mountain Time** (MT) November 19, 2021, regarding third party liability (TPL) in Medicaid.

Effective December 31, 2021, New Mexico Medicaid is implementing changes to third party liability in Medicaid to modify TPL rules related to special treatment of certain types of care and payment.

The Human Services Department is making the following changes:

- 1. Applying cost avoidance procedures to claims for prenatal services, including labor, delivery, and postpartum care services;
- 2. Making payments without regard to potential TPL for pediatric preventive services, unless a determination has been made related to cost-effectiveness and access to care that warrants cost avoidance for 90 days; and
- 3. Making payments without regard to potential TPL for up to 100 days for claims related to child support enforcement beneficiaries.

The changes are being made to comply with requirements of the Bipartisan Budget Act (BBA) of 2018 and the Medicaid Services Investment and Accountability Act (MSIAA) of 2019.

Tribal Impact

There is no impact anticipated for Indian Nations, Tribes, Pueblos and their health care providers.
