**RE: Tribal Notification to Request Advice and Comments Letter 24-05: Renaming Human Services Department (HSD) to Health Care Authority (HCA) per SB 0016**

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Health Care Authority's (HCA's) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HCA, through the Medical Assistance Division (MAD), is accepting comments until **5:00 p.m. Mountain Time (MT) Thursday, June 6, 2024**, regarding state plan amendment (SPA) 24-0002, Renaming Human Services Department (HSD) to Health Care Authority (HCA).

Effective July 1, 2024, New Mexico Medicaid will be reorganized which will rename the Human Services Department (HSD) to the Health Care Authority (HCA). The reorganization allows the change of HSD's powers and duties, providing for transition, transferring functions, personnel, money, appropriations, records, equipment, supplies, other property, contractual obligations and statutory references, amending and repealing sections of the NMSA 1978; reconciling conflicting section of law in Laws 2019 by repealing Laws 2019, Chapter 211, Section 11.

**Tribal Impact**

HCA does not anticipate any impact for Indian Nations, Tribes, and Pueblos and their health care providers with this change.
