Clarification to Notice of Public Comment dated August 22, 2018 -

NM.0173.R06.00 Developmental Disabilities Waiver Amendment and Fee Schedule

On August 22, 2018, the State of New Mexico Human Services Department (HSD) through the Medical Assistance Division (MAD) released a Notice of Public Comment regarding the Developmental Disabilities Home and Community-Based Services (HCBS) 1915 (c) Waiver amendment and fee schedule.

HSD/MAD received feedback that the table included in the notice was unclear. HSD/MAD wanted to clarify that **the number of recipients being served through the DD waiver is not being reduced**. HSD/MAD would also like to clarify the following important points regarding the federal waiver requirement to project an **Unduplicated Number of Participants (UDR)** with its DD waiver amendment submission:

- The UDR count is a projection of future allocations to the DD waiver and developed based on information that is available at the time of the projection. In State Fiscal Year (SFY) 2016, HSD/MAD projected the UDR count for the DD waiver based on data and information that was available at that time for SFYs 2017-2021.
- 2. The table provides a comparison between a projected number to be served and the actual number that were served. To develop the projection, HSD/MAD estimates the amount of the general fund appropriation for the DD waiver in future years, the number of waiver allocations that may be provided in future years, and the number of transfers between the DD waiver and the Mi Via self-directed waiver. If the actual general fund amount appropriated for the DD waiver is less than projected, then the number of participants served will be fewer than the UDR projection.
- 3. When the number of participants served is fewer than the UDR projection, HSD/MAD is required by the Centers for Medicare and Medicaid Services (CMS) to update its UDR projection for future years accordingly. It cannot update retrospective years.

## The updated table below reflects the following information by DD Waiver Year:

- the actual number of participants served;
- the projected UDR count by year; and
- the updated UDR count for Waiver Years 3, 4 and 5. Because the UDR count cannot be amended retrospectively, Waiver Years 1 and 2 remain unchanged from the original projection.

<sup>\*</sup>The decrease in the number of DD waiver participants served is due primarily to transfers to the Mi Via self-directed waiver and attrition.

Impact: The number of DD waiver participants currently being served is not being reduced. There is not a decrease in services or a financial impact to participants currently receiving services under approved Individual Service Plans/budgets or to their healthcare providers.

The State intends to submit the DD waiver amendment to the CMS in October 2018.
