BHPC Vision:

The council speaks for infants, children, youth, young adults transitioning to adulthood, adults, the elderly and their families in the on-going implementation of a consumer-driven, fully integrated, outcome-based, statewide comprehensive system of wrap around behavioral health services.

Purpose of CASC:

The purpose of the CASC is to help improve the quality of life for our children, adolescents, and family members. To achieve this, we create a safe environment where their concerns are affirmed, their voices are represented, and their needs inform action steps.

Discussion of CASC Membership:

To become a member of the CASC, a declaration of interest is all that is needed. Subcommittee membership is not Governor-appointed.

CASC Meetings:

The CASC meets from 1 PM until 3 PM on the second Tuesday of even-numbered months (February, April, June, August, October and December).

CASC Election of Officers:

The CASC has two co-chairs: one is a state agency representative and the other is a non-State Agency representative. The state agency co-chair is appointed by the Children, Youth and Families Department.

Patricia Archuleta is the state agency CASC co-chair.

Monica Miura nominated herself to serve as the non-state agency co-chair of the CASC. Sherri Rhoten seconded the nomination of Monica.

Sandtina Melendrez nominated Lisa Trujillo to serve as the non-State Agency co-chair. Lisa Trujillo declined the nomination.

Monica Miura was elected the non-state agency co-chair by acclimation.

Monica asked CASC members to provide solid recommendations to the BHPC and the Behavioral Health Collaborative on behalf of children and families.

Monica detailed the many efforts she is involved in: Behavioral Health Needs Special Education Workgroup, Building Bridges Children's Residential Workgroup, CYFD Protective Services Workgroup, CFPSW trainer and representative to the New Mexico Credentialing Board for Behavioral Health Professionals, CFPSW Steering Committee, and Systems of Care and Settlement Agreements workgroups.

September Recovery Month:

Natalie Rivera provided information about the 2022 September Recovery Month. Behavioral Health Services Division is sponsoring 17 community events. She will send out additional information about them.
