- Clarification regarding the definition of “RLD board approved supervisor” is needed.

8.321.2.20 Crisis Intervention Services

B-1- Eligible providers- Telephone Crisis services

- References independently licensed BH practitioner in the title but goes on to list providers at multiple levels.
 - Recommend removing the Independently licensed BH practitioner reference from the telephone crisis services heading.

8.321.2.37 Supportive Housing Pre-Tenancy and Tenancy Services

A-2 -Eligible providers and practitioners

- References behavioral health professional licensed in the State of New Mexico, certified peer support workers or certified family peer support workers.
 - Recommend expanding eligible providers to include community support workers, community health workers and case managers.

8.321.2.39 Therapeutic Interventions

A- Eligible providers- limited to independently licensed providers

- Will non-independently licensed providers be eligible based on 8.321.2.9 E
