Interested Parties:

The New Mexico Health Care Authority (HCA) Medical Assistance Division (MAD) is providing notice on plans to submit a State Plan Amendment (SPA) request to increase rates within the Family Infant Toddler (FIT) program for specific services provided on or after February 1, 2025.

These changes are being made due to the Early Childhood Education and Care Department (ECECD), FIT Program, receiving a special appropriation of \$2,000,000 from the FY25 State Legislature to increase rates for FIT Program services funded under State and Medicaid funds. These services are provided under the Early Periodic Screening Diagnosis and Treatment (EPSDT) Special Rehabilitation section. The State General Fund match will be paid through the ECECD.

The estimated financial impact is \$2,790,179 (in federal funds) for FFY25.
