Profile of the TANF Population

- ♦ 16,981 cases
 - > 20% increase from May 2008 14,159 enrollment;
 - lowest enrollment was 13,518 in July 07
- 42,639 individuals: 15,672 adults and 26,967 children (23% increase)
 - May 2008: 35,215 individuals
 - July 2007: 33,334 individuals
- Family composition
 - Average household size is 2.5
 - > 15% are 2 parent families
 - > 51% are 1 parent families
 - > Almost 72% are Hispanic
 - Ages of head of households:
 - 48% between 20 -29
 - 30% between 30 -39
 - 14% between 40 49
 - 8% are 60 years or older



Profile of the TANF Population

- ◆ Of the 15,672 adults receiving TANF cash assistance benefits, **9,248** are required to participate in a work activity:
 - > 57% Report earned income
 - > 3% Report unearned income
 - > 4% Report both earned and unearned
 - > 36% Report no income



Program Goals

- Four goals of TANF
 - Provide assistance to needy families
 - > End dependence of needy parents by promoting job preparation, work, and marriage
 - Reduce out-of-wedlock pregnancies
 - Encourage formation of two-parent families
- ◆ The purpose of the New Mexico Works Program is
 - ➤ **To improve the quality of life** for parents and children by increasing family income, resources and support.
 - ➤ To increase family income through family employment and child support and by utilizing cash assistance as a support service to enable and assist parents to participate in employment.



Nationally — What We Know About TANF Leavers

- ◆ 75 -85% of families eligible for welfare were served in AFDC.
- ◆ 42% of eligible families being served through TANF
 - time limits & sanctions
- Increase in low-income single mothers without work or welfare Disconnected Single Mothers
 - Increase from 11.7% in 1995 to 20% in 2005 (Blank and Kovak, 2008).
 - > Research show that these disconnected adults are more likely to have significant barriers to self-sufficiency, including disabilities.
- "Disconnected Welfare Leavers in Colorado" Lewin Group, March 2009
 - Disconnected leavers differ from leavers with earnings in several key ways. They are more likely to be
 - Slightly older,
 - Hispanic or non-white,
 - lack a high school education,
 - married or living with a partner, and;
 - to have younger children than leavers with earnings.



National Trends, continued

- Sources of income for those left TANF
 - Most common is SNAP two-thirds receive this benefit
 - ➤ 30% receive child support
 - > 29% financial assistance from family or friends
 - ➤ 17% live with other household members (other than spouse) who have earnings
- Reasons for not working
 - > 26.5% poor health
 - 23.2% cannot find a job
 - ➤ 14.9% no childcare
 - > 2.8% caring for ill or disabled family member




New Mexico data

- ◆ 40% of TANF adults are exempted from work requirements
 - > 3 federal work exemptions and 6 additional state exemptions.
- Exemptions as of March 2009
 - > 1,746 caring for a child under 12 months old
 - > 1,513 incapacitated
 - > 629 Pregnant, 3rd Trimester
 - > 226 other/good cause
 - > 162 caring for an incapacitated household member
 - > 49 Age 60 or older
- ◆ 73% of TANF caseload have been receiving benefits for 12 months or less
- 9,627 households have reached 60 months life-time limits since 2002
- 920 sanctioned (May 2009, 1st 3rd level sanctions)


New Mexico Maximus Study 1999-2003

- Most important barriers to employment are physical and mental health problems, learning disabilities, having to care for a sick or disabled family member.
- ◆ Health problems were the most common reason cited by unemployed respondents for not working.
- Multiple barriers were common.
- ◆ Those with physical health problems were also more likely to have mental health problems and a learning disability.
- Older respondents and whites were more likely to have physical/mental health problems.
- Educational deficits correlated to learning disabilities.

Services and Providers: FY 2009 NMW Service Delivery Areas





TANF Funding – Appropriations & Costs

- ◆ TANF funding is spent in Three Primary Areas
 - Cash Assistance
 - Support Services (for TANF recipients, TANF eligible and non-TANF eligible)
 - Administrative Costs for HSD (primarily for salaries for ISD workers)
- ARRA Funding
 - Potential for NM = \$55,289,050
 - TRD Working Families Tax Credit: \$16,586,715
 - Balance = \$38,702,335
 - ARRA Spent on Cash Assistance in FY09: \$11,052,800
 - Balance = \$27,649,535

- Outlook for FY 12
 - TANF Block Grant = \$110,578,100
 - Carry Forward = estimated \$7,699,643 to \$11,892,948
 - > TOTAL REVENUE = \$118,277,743 to \$122,471,048
