V. BACKGROUND SUMMARY

The Human Services Department (the Department), through the Medical Assistance Division (MAD), is proposing to repeal a number of Medical Assistance Division (MAD) provider rules in order to reduce the number of specific rules and consolidate those services into broad service rules, such as repealing the 17 unique behavioral health service rules into one broad rule that includes these 18 services.

The following rules are being proposed for repeal on January 1, 2014:


