V. BACKGROUND SUMMARY

The Human Services Department (the Department), Medical Assistance Division (MAD), is proposing the repeal of 8.315.4 NMAC, Other Long Term Care Services, Personal Care Option Services.

The Personal Care Option (PCO) service was available only through the Coordinated Long Term Services rule which was repealed effective January 1, 2104. Replacing the Coordinated Long Term Services rule is the new Managed Care rule NMAC 8.308. The services corresponding to PCO are found specifically in 8.308.12 NMAC, *Community Benefit Package*, which serves as the basis of the benefits, authorizations, and all actions formerly associated with PCO, effective January 1, 2014.

VII. EFFECTIVE DATE

The Department proposes to repeal these rules effective February 15, 2014.
