IV.	Medicaid Budget Projections	Nancy Smith-Leslie began the report with the enrollment projection. Nancy explained that children's enrollment numbers were listed separately. Nancy also reported that the base population is projected to be 601,000 by June 2015. Nancy reported further on reasons for enrollment changes such as change of categories, demographic mix more balanced, more younger population served, expansion enrollment increasing, and less retroactive enrollment. 		For FY14 Nancy Smith-Leslie pointed out FQHC reconciliation payments were lower than previously estimated, and the rate for primary care provider's expenditures have increased. On the revenue side for FY14, Nancy Smith-Leslie reported the school based allowance projected revenue is now recognized as an allowance and explained APS needs to pay state share for Medicaid school based programs.			
		For FY15 Nancy Smith-Leslie reported on fewer than estimated Mi Via clients coming onto the program in the last few months of FY15 and a decrease of physical health expenditures due to a significant amount of members moving from physical health to long term services cohorts. Nancy Smith-Leslie reported the Division has begun an audit process to understand the data and discussed the topic further with the committee on possible reasons. Nancy Smith-Leslie also reported on an intergovernmental transfer agreement with UNM, that actual claim experience for the hospital rate increase was less than projected.			
		For FY16 Nancy Smith-Leslie reported increasing behavioral health expenditures partly due to a new service, applied behavior analysis. Nancy Smith-Leslie also reported on health homes pilot sites soon to begin, additional county revenue generated by gross receipts tax, and a work group being developed to look at emergency room usage.

V.	Director's Report	<ul> <li>State Innovation Model (SIM) group held summit with Department of Health. HSD and DOH are developing a plan for all payer claims database.</li> <li>A work group is forming with managed care organizations and MAD staff to look at emergency room usage among all Medicaid populations, especially non emergent use.</li> <li>An update on Senate Bill 42 that passed in 2015 session to provide Medicaid eligibility for the jail population. The Medical Assistance Division is working with Corrections Department, counties, and managed care organizations. Molina has begun a video conference pilot to work on care coordination prior to release. Also developing MOU to share and exchange data.</li> <li>Health home implementation is on track for January 1, 2016 implementation. The SPA will be submitted at the end of August 2015.</li> <li>Myers and Stauffer is conducting evaluation of claims payments from 2014. An audit will begin of managed care organization claims with a conference with each organization. VI.	Transition to ICD-10	Russ Toal provided an update on the nationwide compliance of Transitioning from ICD-9 to ICD-10 medical code set for medical diagnoses and inpatient hospital procedures, on October 1, 2015.  Russ Toal updated the committee on testing, contingency plan, compliance, outreach, collaboration, provider communication, claims processing, monitoring, reporting, and system evaluation. Russ explained the levels of testing internally, internal with other state systems, and external testing. Russ pointed out that claim submitters not compliant by 10/1/15 would not be able to submit claims.  Russ Toal responded to committee questions and concerns regarding clearinghouse based information. VII. Behavioral Health Upda Behavior Analysis	Dauna Howerton provided an update on Applied Behavior Analysis, a new evidence based service delivered to Medicaid members identified with Autism Spectrum Disorder. Dauna explained Applied Behavior Analysis is an intervention type service that brings positive behaviors and meaningful changes to anyone identified with autism spectrum disorder. Dauna further explained the services break into 3 stages and a client must go through each stage as part of a comprehensive treatment plan. Dauna Howerton explained the stages of screening, assessment, and implementation.  Dauna explained how the service requires behavior analyst certified board providers to deliver the service. Dauna explained once a rule change occurs recruitment for certified providers can begin.  Dauna also reported on weekly work group with managed care organizations, providers and other state agencies, meeting on how to deliver the service, and to discuss prior authorizations, level of care, and array of services that states must have in place. UNM is also involved to help connect the managed care organizations with the agencies to meet goals such as provider training. VIII. Public Comment	Ellen Pinnes-Question regarding Medically Fragile Waivers. Ellen presented a question whether basis for eligibility will change. Nancy Smith-Leslie responded, no eligibility changes.  Lisa Rossignol-from the Parents Reaching Out organization requested a status on waiver waitlists so that families could move forward. Nancy Smith-Leslie clarified information and stated allocation letters had been sent out however many packets were not returned. The committee discussed the problem that hundreds of packets is a resource issue.  Nancy Rodriguez of NM Alliance for School-based health care, stated that she volunteers to participate in group looking at emergency room usage and stated that school based health centers help educate the public and the work group should consider her as a resource.
