As the single state agency responsible for Medicaid programs and services in New Mexico, the Human Services Department/Medical Assistance Division (HSD/MAD), in accordance with 42 CFR 447.203, has developed methods to periodically measure and monitor the participation and availability of health care providers in the New Mexico Medicaid program to ensure that Medicaid fee-for-service (FFS) beneficiaries ("recipients") have access to care that is comparable to the non-Medicaid general population.

HSD/MAD has posted the first formal draft of the New Mexico Access Monitoring Review Plan on the Department's website at: <a href="http://www.hsd.state.nm.us/public-notices-proposed-rule-and-waiver-changes-and-opportunities-to-comment.aspx">http://www.hsd.state.nm.us/public-notices-proposed-rule-and-waiver-changes-and-opportunities-to-comment.aspx</a>.

The posted version of the Access Monitoring Review Plan will be considered a draft pending public input from providers, recipients, professional associations, Indian Health Service (IHS) and other tribal health care providers, tribal leadership, and other interested individuals or entities. After the receipt of public and tribal input, submitted comments will be addressed and an updated version of this Plan will be sent to CMS by October 1, 2016.
