The Human Services Department (HSD), Medical Assistance Division (MAD) has updated the Medically Fragile Waiver (MFW) fee schedule, effective July 1, 2020. The updates are based on the MFW amendment to increase rates which was approved by the Centers for Medicare and Medicaid Services (CMS).
