SUBJECT: HOME & COMMUNITY BASED SERVICES – SUPPORTS WAIVER FEE SCHEDULE

The Supports Waiver fee schedule has been updated to now include a rate table for each of the service delivery models: Participant Directed and Agency Based. Billing codes for the Participant Directed Service Delivery Model will remain the same, however for the Agency Based Service Delivery model, several codes have been updated. The Agency Based services codes that were updated include: Assistive Technology, Community Support Coordinator, Customized Community Supports, Non-Medical Transportation, Respite, and Vehicle Modifications. For both models a new modifier "UA" was added to the Community Support Coordinator service codes for both pre-eligibility and ongoing.

There have been no changes to the rates for the Supports Waiver.
