RE: Tribal Notification to Request Advice and Comments Letter 21-11: New Mexico Managed Care Quality Strategy (Quality Strategy)

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Human Services Department's (HSD's) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HSD, through the Medical Assistance Division (MAD), is accepting written comments until **5:00 p.m., Mountain Time (MT) on June 9, 2021** regarding the New Mexico Medicaid Managed Care Program, Quality Strategy (NM Quality Strategy 2021 draft).

The Department is proposing to amend the Quality Strategy as follows: As required by the Code of Federal Regulations, the Quality Strategy must be reviewed and updated as needed, but no less than once every 3 years. The goal of the Quality Strategy is to ensure that New Mexico's Managed Care Program continues to drive towards improving healthcare service delivery and outcomes. Through established standards and a variety of mechanisms, the Quality Strategy will serve as the State's blueprint for monitoring and assessing the Managed Care Organizations, holding them accountable for improving outcomes. HSD is revising the Quality Strategy to integrate recent CMS feedback and to better align quality metrics with the program enhancements.

Tribal Impact: HSD does not anticipate a service or financial impact to Indian Nations, Tribes, Pueblos and their healthcare providers.
