RE: Tribal Notification to Request Advice and Comments Letter 22-03: 2022 COVID-19 Non-Emergency Medical Transportation (NEMT), Nursing Facility (NF) and Hospital Payment Rate Increases

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Human Services Department's (HSD's) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HSD, through the Medical Assistance Division (MAD), is accepting comments until **5:00 p.m. Mountain Time** (**MT**) **March 11, 2022**, regarding 2022 COVID-19 non-emergency medical transportation, nursing facility and hospital payment rate increases.

Effective January 1, 2022, through June 30, 2022, HSD is implementing payment increases for nonemergency medical transportation, nursing facilities and hospitals as follows:

- 1. New Mexico Medicaid will apply a 6.81% rate increase to NEMT providers;
- 2. New Mexico Medicaid will apply a 30% rate increase to short term skilled and custodial nursing facility services for Medicaid members who test positive for COVID-19 and need inpatient care. The rate increase is equal to 30% of the individual facility's high NF rate; and
- 3. New Mexico will apply rate increases of 50% for ICU inpatient hospital services and a 12.4% rate increase for all other inpatient hospital services. Increases are applied to the provider-specific DRG rates and pass-through amounts as well as inpatient hospital stays that are not reimbursed on a DRG basis.

Tribal Impact

HSD does not anticipate a financial impact to Indian Nations, Tribes, Pueblos or their health care providers as they will continue to be reimbursed at the OMB rate.
