RE: Tribal Notification to Request Advice and Comments Letter 24-24: Proposed Medicaid Home Visiting Fee Schedule

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico’s Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Health Care Authority’s (HCA’s) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HCA, through the Medical Assistance Division (MAD), is accepting written comments until **5:00 p.m., Mountain Time (MT) on November 28, 2024**, regarding proposed implementation to the Medicaid Home Visiting Fee Schedule.

This is the newly developed fee schedule for the Medicaid Home Visiting Program.
