Hurricane Irma Evacuees Applying for Supplemental Nutrition Assistance

Program (SNAP) and Medicaid Information

New Mexico is committed to providing flexibility to serve Hurricane Irma evacuees. New Mexico has chosen to serve applicants through the Expedited SNAP rules.

The following procedures apply to people who at the time of the disaster or mandatory evacuation order:

- Were residents of a county that received a Presidential disaster declaration for Individual Assistance (current disaster declarations can be found at https://www.fema.gov/disasters);
- Evacuated to another State; and
- Did not receive SNAP benefits in the month of September 2017.

New Mexico will serve applicants through expedited SNAP rules:

- The FAA will consider applicants identifying themselves as evacuees from Hurricane Irma to have met the criteria for expedited service if an application is received from evacuees by September 30, 2017 (applications received on October 1, 2017 or later will be screened under normal procedures and not follow this process):
- The FAA will process these cases using the existing expedite procedures found at 8.139.110.16 NMAC;
- The FAA will screen applicants for duplicate participation through its eligibility system and contact the home State prior to issuing benefits:

• Each office must track the Hurricane Irma applications submitted weekly using the Weekly Reporting Sheet. At the end of each week, weekly reports should be submitted to their respective ROM's who will forward to Marisa Vigil at Marisa.Vigil@state.nm.us.
