The HUMAD form is used to notify the client about their pending verifications. The pending verifications are necessary to determine the eligibility of the client. Trigger #3: Expedited SNAP for postponed mandatory verification(s)
You are approved for expedited SNAP. If you do not provide the proof(s) listed below, your benefits will end. Your benefits may change based on the proof(s) you provide. If your benefits change or stop, we will send you a notice.

Trigger #4: If the only verification pending is citizenship for an approved Medicaid case. This trigger shall not print on 2nd HUMAD or on the Extension HUMAD. (Not available on the Manual HUMAD)

Your application for Medical Assistance has been temporarily approved for 95 days. To continue getting Medical Assistance, Federal Law requires proof of citizenship. Providing proof of citizenship is a one-time process. Your Medical Assistance will stop if you do not provide proof for the people listed below by the due date.

If you were born in the United States, a U. S. birth certificate is the easiest way to establish proof of citizenship.

If you were born in the United States and do not have a birth certificate, please complete the following section. By providing the following information every effort will be made to verify your birth certificate through the New Mexico Department of Health **or** we will provide you the documents necessary to obtain birth certificates for those household members born outside of the State of New Mexico.
