RE: Tribal Notification to Request Advice and Comments Letter 20-02: 8.200.510 NMAC, Medicaid Eligibility-General Recipient Policies, Resource Standards.

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Human Services Department's (HSD's) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HSD, through the Medical Assistance Division (MAD), is accepting written comments until **5:00 p.m., Mountain Time (MT) on March 12, 2020** regarding proposed amendments to the New Mexico Administrative Code (NMAC) rule 8.200.510 NMAC Medicaid Eligibility-General Recipient Policies in order to implement the 2019 Federal SSI and Spousal Impoverishment Standards for the Medical Assistance Program categories of eligibility effective July 1, 2019.

These changes will affect how much the community spouse can keep monthly and how much the patient pay amount will be calculated monthly for the institutionalized member. The personal needs allowance that the institutionalized member can keep monthly is also going up.

The Department is proposing to amend the rule as follows:

## 8.200.510.8 NMAC

A new mission statement is being added that will guide the continued development of our Department's organizational culture and strategy.

## 8.200.510.12 NMAC

- Amended to reflect the increase in Personal Needs Allowance (PNA), for July 1, 2019.
- Amended to reflect the increase in the minimum monthly maintenance needs allowance (MMMNA) for July 1, 2019.
- Amended to reflect the increase in shelter expenses minimum of the community spouse for July 1, 2019.
- Amended to reflect shelter expenses maximum of the community spouse for July 1, 2019.

Section 9-8-6 NMSA 1978, authorizes the Department Secretary to promulgate rules and regulations that may be necessary to carry out the duties of the Department and its divisions.

## **Estimated Total Financial Impact**

HSD anticipates minimal financial impact as a result of the rule change. The increase in deductions would allow the community spouse to live more comfortably in their home.

# **Tribal Impact**

HSD anticipates a positive tribal impact as a result of these rule changes as Native Americans would more likely be eligible for Medicaid due to an increase in the deductions for institutional care Medicaid.
