SUBJECT: MEDICALLY FRAGILE WAIVER FEE SCHEDULE

The Human Services Department, Medical Assistance Division has updated the Medically Fragile Waiver (MFW) provider fee schedule to implement a provider rate adjustment, effective July 1, 2019. Rates for Nursing RN, Nursing LPN, Occupational Therapy, Physical Therapy, Speech Language Pathology, and Case Management services will be increased.
